We're two quarters into 2019, and buyout multiples in the US remain above 12x on a median basis, according to PitchBook's US PE Breakdown Report. Quarterly readings from 2015 to early 2016 were in the 9.3x to 10.5x range, with multiples gradually building over the past few years. Though high, investors have gotten used to such buyout multiples.
