If polling agents are found having a temperature above the prescribed limit, then their reliever shall be allowed by Presiding Officer. The District Education Officers (DEOs) and Returning Officers (ROs) have been instructing to keep enough polling/counting staff in reserve in case any official displays symptoms of Covid-19.

Gloves for voters, online nominations, sanitisers ...

The Presiding Officer shall allow a voter who is visually impaired or blind or is unable to distinguish symbols or who suffers from any other physical disability to be accompanied into the Polling Unit/Voting Point Settlement/Voting Point and be assisted to vote by a person chosen by him/her, other than an election official, a polling agent or a security personnel on election duty.

ELECTORAL COMMISSION

Each officer elected must qualify and fill the office to which he is chosen, with or without installation, at the first regular meeting in the month of July succeeding his election, unless excused by a vote of the Council, and must present himself for installation at the time specified in the notice issued by or through the State Deputy or District Deputy, unless excused by such officer.
