Illegal income is still taxable since there is no exception excluding it in the tax code. When there is not an explicit exception, gross income is “all income from whatever source derived.” (LO 2.1) 5. Qualified dividends are taxed at either 0% or 15%. The 0% rate applies for taxpayers in the ordinary income tax brackets of 10% and 15%.
